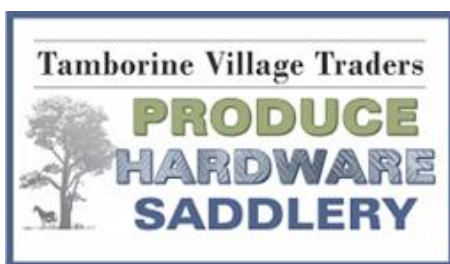
### Hendra Vaccination

**THIS IS A HENDRA VACCINATED EVENT if you are from a High-Risk Hendra Area, if you are from a low risk area, please apply for an exemption to compete (see DPI map for Hendra Areas and applicable postcodes)**

- Hendra Vaccine Boosters must have been administered within the previous 12 months OR
- The first of the two initial vaccines must have been administered before the event.
- Exemptions may be considered and should be applied for via [tamborineequestriangroup@outlook.com](mailto:tamborineequestriangroup@outlook.com) (please note that horses that have never had a vaccine will not be considered for an exemption.)
- **Microchip numbers must be provided with entry.**
- The committee reserves the right to conduct random checks of Hendra vaccination compliance throughout the weekend.
- Hendra Vaccination does not replace good biosecurity practice and a horse health declaration must still be presented on arrival to the event

### Rules & Regulations

- ~ Riders in all classes must be a current financial EA member.
- ~ Horses in EVA95 and above must have current EA registration.
- ~ The event classes 1 through to 13 will be conducted under Equestrian Australia National Eventing Rules/FEI rules.
- ~ Free Base Registration is available on the EQ website for all other horses.
- ~ Substitutions of horse and rider will be accepted up until 25<sup>th</sup> October 2021, as long as it is within the same class.  
No other substitutions will be considered.

## **RESERVATION OF RIGHT**

### **EA 507.7 RESERVATION OF RIGHT**

The Organiser reserves the right:

- To cancel any class or event.
- To divide any class.
- To transfer competitors between sections of a class.
- To alter the advertised times.
- To refuse any entry, with or without stating the reason.

**Use of Scooters and motorized vehicles at the venue:** The cross-country course must be walked on foot only. Permission may be sought from the TD/OC to use a scooter or motorized vehicle.

**Scoring:** We will be using the Equipe AB App for the event and a draw/timetable will be published prior to the event

**Cross country maps:** Will be available online via the Equipe AB app once signed by officials and posted on the official notice board

**Back Numbers:** Riders will be emailed a template and will be required to print out two copies.

**A farrier will be on call for the duration of the event.**

**Riders Representatives will be published prior to the event.**

**Photographers** wishing to take photos of competitors/at the event/or on the grounds **MUST** apply to [tamborineequestriangroup@outlook.com](mailto:tamborineequestriangroup@outlook.com) for approval and supply TEG with the required documentation. Only approved photographers have the right to sell or use any images from within the grounds.

**EA 515.2.7 CCN Objections** Only the owner, or his authorised agent, or the rider of a horse taking part in the competition is entitled to lodge an objection. Protests must be in writing, signed by the person making the protest, and presented personally to the Event Secretary or the Technical Delegate, as the case may be, together with any supporting evidence, names of witnesses and the necessary minimum deposit of \$50. Protests concerning the eligibility of an athlete or horse or to the conditions of the arena: not later than 30 minutes before the start of the relevant competition; Protests concerning an obstacle, or the plan or length of the course for a jumping competition: not later than 15 minutes before the start of the competition; Protests concerning the cross-country obstacles or courses in Eventing not later than 6pm on the day before the relevant competition; Protests concerning irregularities or incidents during a competition, or the classification of a competition: not later than 30 minutes after the announcement of the results or the posting of results on the event notice board. Any person making a protest should, if possible, secure witnesses to the incident and any other form of evidence, and either bring them to the body before whom the protest is lodged, or obtain written statements from them, duly signed, together with their names and addresses.

- ~ All dogs must be kept on a leash. Please pick up after your dog.

### YARDS

Yards are \$55 for the duration of the event – build own yards for allowed \$11 per yard

### YARD BOND

\$20 - Refundable available **ONLY** at the event after inspection from the office

### LATE ENTRIES

**ALL LATE ENTRIES WILL INCURE A \$50 LATE FEE and are non-refundable.**

### REFUNDS

**NO Refunds after original close of entries 11/10/2021 (refunds will not extend into late entry time frame if its extended)**

- Refunds prior to close of entries will attract a 10% administration fee.
- If the event is cancelled prior to commencement, there will be a 20% administration fee withheld from nominations.
  - If they event is cancelled but has already commenced **NO REFUNDS WILL BE ISSUED**

### OTT REWARD SERIES

- the actual winner of the special award, you cannot send a Prize money will be allocated to the horse with the lowest penalties, a prize of \$200, second lowest \$125 and third lowest \$75.

### Eligibility

- Maximum 4 years off the track from last official start or trial as of 1<sup>st</sup> January 2020
- Must supply Horses Race Name (which will be checked for eligibility)
- Winners will be given their cash prize after promoting QRIC via social media and/or letter of appreciation to QRIC <https://qric.qld.gov.au/>.
