# REA Wagga Wagga Dressage Club – Conditions and Information Sheet

Events will be held in accordance with current EA rules as amended, except where FEI rules apply. The REAWWDC and REAWWHT committees may grant exemptions to the rules for special promotional competitions. The onus is on competitors to know the rules. The information and conditions below are relevant for competitions held by both REAWWDC Inc and REAWWHT Inc.

1. Entries will only be accepted on [www.nominate.com.au](http://www.nominate.com.au). These entries must be paid by credit or debit card.
2. All competitors must abide by current regulations as set down by the NSW DPI in respect to travelling and horse events. All competitors are to provide Property Identification Code numbers when entering.
3. Only horses that are entered for competition are permitted on the grounds during an event, unless prior approval is sought from the Organising Committee.
4. A rider may not enter more than two horses in one competition without prior approval of the Organising Committee. If there are fewer than 10 entries in a competition the Organising Committee cannot guarantee the recommended minimum of 90 minutes between draw times for horses with the same rider.
5. Entries will be accepted in order of receipt of nomination which must include ALL horse/rider/EA details. In the case of oversubscription, a short reserve list will be made. Riders/owners on the reserve list will be given the option to transfer to another competition. If there are insufficient cancellations in the draw, riders on the reserve list will be offered a 50% refund of entry fees.
6. A horse's rider may be changed no later than 40 minutes before the start of the event. A rider may not be changed if the horse/pony has already been ridden at the event venue either in warm up or in competition. This means one rider per horse for the whole event.
7. After the close of entries, a competitor may only substitute a horse/pony with the approval of the Organising Committee. Such substitution can be made no later than 48 hours prior to the event.
8. Dressage draw position cannot be changed without the permission of the Organising Committee.
9. Horses/ponies cannot compete in classes below their graded level, unless they compete *hors concours* (non-competitively). This applies to horses that have grading points at Elementary level and above. *Hors Concours*: Riders wishing to ride HC must declare their intention in writing prior to the start of the competition.
10. Horse Identification (bridle number) must be supplied at time of entry for all Dressage competitions. When competing, two numbers must be displayed - one on each side of the horse, preferably attached to the saddle cloth or bridle. Number must be on horse/pony at all times (unless in yard/stable). Numbers must be clearly legible.
11. It is courteous to notify scratchings to the Organising Committee as soon a competitor knows that he or she will not be able to compete. Horses/ponies which are scratched before the closing date of entries will receive a full refund minus the administration fee. Scratchings after entries have closed will receive a maximum of 50% refund for entries on presentation to the Organizing Committee of a doctor's or veterinarian's certificate.
12. There will be no refunds for entries with incomplete paperwork or registrations.
13. Callers are permitted. Callers must not distract competitors/Officials in adjoining arenas. No callers are permitted for FEI tests.
14. Safe riding attire (including EA approved safety helmet, appropriate clothing and footwear) is to be worn at all times when riding.
15. Warm-up: Please use designated warm-up areas, be aware of group riding rules, look where you are going, and keep at least 10m from competition arenas. The warm-up arena is to be used only by those directly warming up for competition. Lunging is to occur only in the lunging area.
16. Gear check: All competitors must be gear checked for each competition by the Gear Steward. Failure to do so will entail elimination.
17. Random swabbing may take place. If approached by an Official/Steward/Vet Officer, competitors must allow samples to be taken from their horse/pony for drug testing.
18. Video cameras and equipment: This gear is to be kept at least 10m from competition arenas, preferably at the C or A end of the arena.
19. Stallions: Stallions are to be stabled. Their horse floats, yards and stables must display green Stallion Identification Discs at all times. Stallions are to be handled as per EA guidelines.
20. Dogs: Please leave canines at home. If brought onto the venue, dogs must be restrained at all times and must be restricted to the carpark. A fine of \$100 will be issued to the owner if a dog is found unrestrained or in an area other than the carpark. Continual non-compliance with these rules may result in the dog in question being removed from the grounds and impounded.
21. Competitors are expected to follow the Code of Conduct as set by the EA. Any abuse of officials, judges, other competitors or horses will not be tolerated and a Yellow Card may be issued by the Chief Steward.
22. Yards/Stabling and Camping are all available at CSU Equine Centre. All must be booked on-line through CSU Equine Centre via Nominate/Stables. A fee will apply. Neither REAWWDC nor REAWWHT accepts responsibility for the condition or state of repair of the stables. <https://www.nominate.com.au/Stables/VenueIntroduction.aspx?vid=382>
